ENROLLMENT PROCEDURE

1. Families should contact the Enrollment Coordinator (info@berkeleyrose.org) to schedule an Open House visit and/or to book a Tour as noted in our Admissions Calendar. This gives the family the opportunity to learn more about Waldorf education, the Berkeley Rose Waldorf School and to meet the faculty and parent community. It will be necessary to attend either a Tour or an Open House in order to begin the enrollment process.
2. After you have attended either an Open House or a Tour, please submit your application. Upon submission of an application and payment of the \$75 application fee (\$125 for two or more children), parents will be contacted for an interview. **Applications and fees are due in the school office by Friday, January 19, 2018.** Applications received after this date will be considered if space is available.
3. **Decision letters for new students will be sent on Friday, March 16, 2018.**
4. Upon acceptance by the school, a completed Tuition Contract, and non-refundable payment of a Tuition Deposit (see below) for each student will be due by **March 23, 2018.**
5. The enrollment process is complete upon 1) Payment of Tuition Deposit, 2) Submission of the completed and signed Tuition Contract and, 3) Confirmation of enrollment in FACTS Tuition Management system.

DEPOSIT OF ONE MONTH'S TUITION AND ENROLLMENT FEE

A one-time non-refundable deposit of one month's tuition (1/12 of the annual tuition) for each student is required to secure a space in the class. This annual deposit will be applied toward the final payment for the academic year once the full tuition has been paid, but is otherwise non-refundable. Along with the deposit, an annual Enrollment Fee of \$198 will be due for students. This fee can often be waived for early deposit payment. Please see Enrollment Coordinator for further details.

TUITION ASSISTANCE - PLEASE NOTE JANUARY 19, 2018 DEADLINE

We offer financial assistance to make our school *accessible to all* who value Waldorf education. Reductions in tuition are based on an independent assessment of a family's financial need. Each family must reapply for tuition assistance each year. Applications for tuition assistance are available online at www.berkeleyrose.org. **The financial aid application deadline is January 19, 2018. Tax forms must be received by February 9, 2018.** Later applications may be considered only if funds are still available.

PAYMENT OPTIONS

Tuition payments may be made annually, semi-annually or in 12 equal installments due on the first day of each month, July through June. Any payment received after the 10th of the following month will be assessed a \$75 late fee. Tuition payment is processed through an online payment systems, FACTS Tuition Management System. Details will be provided in your Admissions Acceptance packet.
